Approval of Previous Minutes

• Previous meeting minutes were approved by Board via email

President's Report

- No additional talk about sidewalks along Jumpers. No invite from Chartwell for meeting
 as of yet. Greater Severna Park Council meeting was Tuesday and nothing was brought
 up about sidewalks.
- Tomorrow night girl scouts campout at common area. Will need access to bathrooms. Safety patrol can make extra rounds.
- Clean out shed this fall and get documents that are being store there scanned.

Treasurer's Report

- George provided an overall summary of the budget
- We received an additional 13 assessments for a total of 377.
- We have received additional income from pool guest passes and HOA packets.
- Haven't received Greater Severna Park Council bill. Billed \$35 once per year.
- Online Gateway payment has been stopped
- Purchased stamps
- Taxes due September 30th have been paid
- We have yet to tap into the savings for the year. Will probably have to tap into it for the expense of the pool access cards.
- Second late fee notice to go out to those with unpaid assessments.
- No success so far in collecting on assessments that were paid by check and returned for insufficient funds.

Committee Chair Reports

Architecture Committee: (Ryan Scott)

- 10 ft. wide pedestrian walkway on Benforest a few residents asked to have it opened back up. Community association at the time agreed to allow to close it up. Need to check and see if it's an easement.
- Front footage needs to be resurveyed along jumpers. Typically costs approximately \$4k. Could probably have done for half the price. Lady from County came out and said to

- mow 10 ft. from the road. Fences along Jumpers are in poor shape. Ryan Scott will send letters. Should we plant Leland Cypresses along Jumpers?
- Ryan Scott tracks architectural inquires via a spreadsheet with name, address, date received and date approved/denied.
- Mike Husselbee to look into new landscape bids

Chatter (Lauren Wilusz):

- Lauren asked about the content expectations of the Chatter. It was discussed that the volunteer list is always on the back, contents include hot topics and important dates.
- Office Depot offers discount codes for printing
- Old Chatters are online can use as a reference for content
- Some people have stepped down as court captains
- Lauren asked for listing of addresses. George can provide.
- Next edition scheduled to go out week after Thanksgiving. November 6th is the deadline for submission.

Common Area and Safety Patrol (Mike Husselbee):

Common Area

- Vince Burke put up a new basketball chain net and painted a door.
- Carpet and padding was left on top of the common area dumpster by resident. The resident ended up cleaning the mess.
- Mosquito Man mosquito spraying. Takes care of fleas, ticks and mosquitos. Took care
 of the fly problem as well. Question raised about chemicals used and duration that they
 work. Lasts for 3 weeks. Look into this for July 4th next year.
- Still need to look into trees and replacement cost of pavement.
- Trees located around drain pipes in common area need to be trimmed. Lauren's husband has been edging the grass near the common area. Not part of landscape contract. Land belongs to someone but is not maintained by them.

Safety Patrol

• Nothing to report

Pool Committee (John Mennell)

- We are over budget on ID cards by \$230. Discussed putting stickers on the cards and distributing them for next year, to avoid having them made again. Should we do that or just redo them next year?
- We did hire a gate guard with Anchor this year. Anchor is the one that wanted us to use the cards.
- Ration 9:1, swimmers to guards. One guard was to be checking cards at the gate. This wasn't happening. Guards always had their phones out. Someone needs to police the guards. There was not a lot of follow through with the guard liaison.
- When pool committee has their meetings with Anchor, invitation should be extended to BOD.
- Anchor says that guards should be able to leave when pool closes. Overall thought was that the guards should be required to stay for a half hour after the pool closes to clean up.

- It was expected that some improvement of the guards would be seen, this year from last year, after meeting with the guards. The manager Liz was not good at delegating. She was frustrated with the guards and they wouldn't listen to her. She reported this to Anchor and nothing was done.
- We are considering opening up the bid for the pool contract. It was decided that this was
 too much to take on last year. Pat Magness had indicated that Anchor is one of the better
 pool management companies.
- Discussed having a weekly punch sheet and to incentivize the life guards with bonuses.
- Aleigh Vancaster stepped down as pool committee co-chair. She still wants to be on the pool committee. Need more people on the committee.
- Three companies coming out to bid on pool deck concrete repair.
- Also need estimate for pool cover and resurfacing of pool.
- Vending machine discussed possibility of keeping it.
- Fall cleanup is coming up. Not as involved as spring cleanup. Need to stack chairs and chain them up. Need to take inventory of what needs to be done. Need to have painting party.
- Jim Miller to give estimate on bathroom floors.
- There is a leak along the pavilion roof. Repair needs to be done before winter.
- Garage door needs to be replaced. Email request to Mary Pat. Need to get more than one bid.

Reserve Committee (Mary Pat Bozel)

• A few things have come out of the reserve but nothing major.

Social Committee (Julie Bresson)

- Adult party went well.
- Fall Festival, October Fest and Garage Sale coming up.
- Garage sale is October 3rd. Julie had indicated that the advertising for this is not usually part of her budget.
